

#### **Our Values**

We believe people should always have access to free or low cost first aid assistance.

We recognize the importance of providing free first aid and first aid education to vulnerable people, and people with limited financial means.

We assert the provision of free first aid services and assistance is provided in a culturally sensitive manner, and is offered by us at the same time as relieving poverty and improving their health and wellbeing.

We are committed to supporting and providing practical assistance through the provision of first aid services and assistance to people of limited means.

#### **Aims and Purposes**

St. Andrew's First Aid Australia Inc. shall aim:

- a) to providing first aid assistance and support aimed at relieving poverty, and other risk factors in their lives;
- b) to find suitable and appropriate trained first aid volunteers to assist in our services;
- c) to provide in times of emergency or natural disaster physical assistance to persons through search or rescue and the provision of first aid services to all affected;
- d) to provide welfare and poverty relief through our first aid services and assistance; and
- e) to provide culturally relevant programs and services.

#### **About Us**

1882 was the first year of activity for the St. Andrew's Ambulance Association and 173 cases of accident and sudden illness were removed from the streets of Glasgow and taken to hospital by litter. That year the association provided itself with one ambulance.

In 1899, the Royal Charter was granted, being registered and signed on 02 May the sixty-second year of Queen Victoria's reign.

At a council meeting in that same year, it

was agreed that they carry on the work of the Red Cross Society in Scotland. Following upon this resolution. the Central **British** Red Cross Committee recognized St. Andrew's Ambulance Association as a branch of Cross work Red in Scotland.

In 1900, the Association sent a Base Hospital to

South Africa free of charge to the War Office. In 1908, the Council reported on arrangements by which. the on mobilization, Association the would undertake to assume charge of the Military Hospitals in Scotland. During the Great War, the Association was requested by the War Office to furnish St. Andrew's Ambulance Association units for active service; where they served in casualty clearing stations in France and on hospital ships for the duration.

St. Andrew's Ambulance Association Australia was established as a company under Scottish Charter on 05 April 1976 by



the Director General St. Andrew's Ambulance Association, Dr. Daniel Strachan, OBE.

Under the patronage of legendary WW2 POW Surgeon, Colonel Sir Ernest Edward 'Weary' Dunlop, AC, CMG, OBE, the first Australian Director was Artillery Officer Major General Sir Denzil MacArthur-Onzlow, CBE, DSO, ED who commanded the 4<sup>th</sup> Armored Brigade during WW2 and with Vietnam War Doctor, Group Captain William Land, AM, RFD, AE appointed Surgeon-in-Chief.

> The first Companies were formed at RAAMC Military Hospital Healesville, Victoria, and St. Kilda Private Hospital, Victoria.

> On 02 September 1980, our main base of operations had moved to the Ballarat East Company established at Begonia Hospital, Victoria.

Over the years the organization grew steadily, and members served in countries many including: Armenia, Bangladesh, Bosnia, Chechnya, El Salvador, Iraq, Lebanon, and Rwanda, wide variety assisting a of Non-Government Organizations. This year we had two members volunteering in PNG and Timor-Leste.

On 28 September 2006, the Association incorporated under the name 'St. Andrew's First Aid Australia Inc' (SAFAA) and reformed the Board of Management under the Chairmanship of Tom Hazell, AO. Steven McRae became the Chief Executive Officer and David Alexander-Fleming, JP moved to the position of Vice Chair and Corps Advisor. The Association re-engaged with St. Andrew's First Aid in Scotland and refocused its primary aim to providing first aid with the same trading name as in Scotland.

In 2007, we recommenced public duties, services providing first aid at the Ringwood Highland RSL Games. Marches, The Aboriginal Literacy Foundation Camps, to name a few of our long standing events, and, we began in Australian partnership with Premier Learning (our RTO) to once again offer courses in First Aid.



On 24 May 2008 Dr Anthony Cree, OAM, PhD succeeded Tom Hazell as Chairman and in 2009 Malcolm and Joy Murray, the Earl and Countess of Dunmore became Australian Patrons.

In January 2009, the Commandant-in-Chief and honorary surgeon to the Queen, Colonel Douglas Bremner, TD, conducted an inspection of St. Andrew's First Aid Australia during a private visit.

On 01 December 2011, Charity Status was granted and St. Andrew's First Aid Australia Incorporated became a Public Benevolent Institution. On 23 November 2012 David Alexander-Fleming became President and CEO. We commenced a very successful program with the Australian Army Cadets in Victoria providing them with first aid equipment and training.

In 2016; our fortieth year in operation in Australia, we recommenced establishing First Aid Companies in Victoria. We began exploring different revenue streams and ways to ensure our sustainability. We established the 'Society of St. Andrew' to embrace individuals who wish to support us without joining the Association. Our first Search & Rescue Support Company was also established to support the State Emergency Services (SES) when deployed in the field.

In 2017 we formed St. Andrew's First Aid Pipes and Drums and commenced negotiations with the Victorian State Government about establishing a role for us in the Emergency Control Organization (ECO).

In 2018, The 15<sup>th</sup> Earl of Loudoun, Simon Abney-Hastings, became the Chairman of the Board of Governors, and six long serving members were presented with their Voluntary Medical Service Medal by the UK Consul General for Victoria Chris Holtby, OBE.

We also fundraised and sent three trainers to PNG to increase the level of first aid knowledge along the Kokoda Track.

On 21 May 2018, Her Royal Highness, Princess Anne The Princess Royal, became the Royal Patron of SAFAA.

#### **President's Report**



I am writing this report after returning from the Melbourne Shrine of Remembrance representing SAFAA with my youngest son

Dylan at the annual commemoration for



the Russian ANZACS who served during the First World War. Thirteen years passes so quickly, it feels like only yesterday that the plaque was unveiled by HIH Grand Duchess Maria of Russia. Scotland and Russia share the same Patron Saint: St. Andrew amongst other things.

The Victorian Government have announced that they intend to regulate the First Aid sector under the control of Safer Victoria. This will be undertaken in conjunction with the *Non-Emergency Patient Transport Act 2003* review.

I attended a meeting with one of our Commissioners Steven McRae (CCOM 2006 - 08) to discuss the proposal and although we expect some additional paperwork associated with regulation, we are very confident that this regulation will foster certainty and weed out the cowboys from the industry. With this in mind our Board of Management have spent most of their time ensuring our future compliance will be achievable.

We both has a great chat with Victorian Chief Paramedic A/Prof Alan Eade, ASM before the seminar. Incidentally the CEO of Safer Victoria got his start in first aid in Glasgow with SAFA.

We have finished our second year of a three-year restructure to better use all our volunteers in positions that our organization desperately requires. Many thanks to all those who transferred to Operations and undertook event management roles so seamlessly. Two in particular; Steve McRae and Hayden

McManus have done exceptional work in their new roles, thank-you.

And welcome to Vicki Creed who has taken over the role from Alistair



McInnes who was managing jointly this and some of the administration of our PNG deployment.

I also had the pleasure of re-appointing our Commandant-In-Chief for a further five years. Tony will be supporting the Board of Governors as they slowly expand their scope within SAFAA. This year we saw SAFAA expand and undertake its first overseas deployment in many years. Three of our members went to PNG and shared their first aid skills with local students (see the Overseas Liaison Officers' Report). Fundraising is well underway for next year with the 'Weary Dunlop' dinner on St Andrew's Day at the Heroes Club.

Our first fundraising dinner at the Kelvin Club where 100 members including Weary Dunlop's granddaughter Dianna Dunlop



wearing his miniatures. and guests raised over \$4.000 towards **PNG** the deployment. Many thanks to the countless helpers and supporters

who made this happen, including Mike O'Meara Chair of the Weary Dunlop Foundation. A memento of the deployment was presented to SAFA by our Aid Liaison Manager Commander Alistair McInnes and one of our Governors Ms Annamalia Chimenton.

The CSM has almost fished updated the Dress Regulations to include the green

governments is important for our longterm development as a Volunteer First Aid provider.

Another significant development was the formal notification from Buckingham

Palace that the Princess Royal (Princess Anne) is also to be our Australian Patron. It was suggested that she could be our Guest of Honour at the Peers Ball reenactment in Edinburgh in 2022. This function being held by the Registry of Scots Nobility will be in aid of St Andrew's First Aid in Scotland and in Australia. This year we will not be holding the Annual St Andrews Day Reception at the Melbourne Club, due to the clash with the Weary Dunlop Dinner planned for the same day raising funds for 'Operation Kokoda Assist'.

It is our intention to continue the St Andrew's First Aid Reception tradition next year and if that is not possible, we will choose an alternate date for a SAFAA Reception, possibly at some other significant Scottish date given the busy calendar around St Andrew's Day.



Finally, I would like to especially thank all those who have worked so hard to make a successful year for SAFAA. We are grateful for the generosity of our Patron in Australia, the Earl of Dunmore for his involvement and ongoing support. Also,

the Governors, including the Earl of Loudoun, the Chair of the Board of Governors, who have been able to provide important service to SAFAA. Our volunteers turned out 'enmass' (thank you) under the watchful eye of Corps Sergeant Major Peter Barker. The parade was led by the Hon. Simon Abney Hastings - Earl of Loudoun and Governor of SAFAA followed by Pipers, Drums and Dancers accompanied by the Clans. All mustered at the Treasury Gardens in Spring Street marched down Collins Street to Swanston Street watched by thousands of onlookers. A very large crowd indeed. A big thank you to our volunteers all for making us look good. A job well done.

This year will bring about many challenges. One in particular is the recruitment of qualified volunteers to service our community. Our team is increasing slowly, and we are always open for more volunteers.

With the increase in volunteer numbers comes the challenge of financing the resources for them to carry out first aid duties. The Chief Commissioner and Commanders will be meeting in February 2020 for a special meeting to develop a program to ensure our financial future. Until then slow growth is the catchphrase for the day.

#### **Operations Report**

This is my first full year in the role of COO, taking over from Marcus who suffered horrific injuries in a workplace accident. He left in place a sound foundation that has seen us grow, particularly in Bendigo under Jordan Wilkinson and the Peninsular under Matthew McLear.



Bendigo Company have held two fundraisers, with a third to come soon. Our first - St. Andrew's Day, 2018 - was poorly attended due to a heat wave (48 degrees!), and only managed to raise a small amount of money. The folk who attended, however, said they'd come along to any more Scottish Evenings, so we locked Burns Night this year in at the Pub -Hibernian Hotel, who allow us the use of function rooms at no charge. Accordingly, that evening raised a lot more, and we played outside for the hard-drinking regulars, shook the donation boxes, and made heaps more dollars.

Operationally, a fairly quiet time with the 2019 Scots Day Out in Bendigo, followed by a Country Music Concert, also locally. Being an outdoor concert on a hot, sunny

day, much money was raised dispensing sunscreen (not selling - just a discreet sign by the big dispenser suggesting a donation, perhaps). Our donation boxes are getting a very good workout!

Owing to the tightening of Victorian First Aid (provision of) Regulations, we were unable to provide support at the higher requirements to place a first aid post at the Bendigo 'Oktoberfest,' with its attendant booze, party drugs and troublesome patrons ... definitely better left to the paramedics, those functions!



Once again, we supported the Ringwood Highland Games, as well as the inaugural 'Tartan Day' street parade in Melbourne.

We are fortunate in having a few pipers and drummers on our books, so local events can be supported with the appropriate music. Thank you to Jordan



for his leadership in recruitment, and with our CSM, we welcome new members Rod and Wendy Tamblyn provide us another piper & drummer respectively.

We have supported the Aboriginal Literacy Foundation again this year, providing both first aid and managerial support at their camps each year held in Ballarat, and another six in locations around Victoria.

The Literacy and Heritage Camps have provided a wonderful opportunity to make a real impact on hundreds of students every year. Our evaluation of the students



on completion of the camps have highlighted some significant progress and improvements in literacy and numeracy

skills, resulting in the vast majority of them moving closer to and/or beyond national benchmarks.





Over the course of the financial year we provided 164 attendances of first aid support to over 50,000 combats from the Glen Lachlann Estate College of

Arms in Melbourne, Sydney and Malta.

#### **Our Work Abroad**



In February 2019. Steven Ward, Alistair McInnes and I travelled to Papua New Guinea to roll out our first aid training package. The package is designed to enable

practical first aid classes to those who would otherwise not have the opportunity. The trip also enabled the SAFAA members to raise the profile of our organization in PNG.

On arrival in PNG with senior customs and reserve police Brian Lillywhite. member, detailed the Brian requirements for importing large quantities of medical We supplies. exchanged business cards and Brian said to call if we ever have any difficulties. Alistair worked with Brian some ten years ago.

Continuing our networking we met several ex-pats in government and private enterprise whilst staying at the Grand Papua Hotel. Between 5:30-6:30pm each evening selected hotel residents can use the executive lounge for 'happy hour'. In **PNG** amongst the ex-pat

community this is where most of the networking is done.

After our brief stay in Port Moresby we flew to Popondetta on the north coast of Papua in the Oro Province. On arrival we hired a Toyota Land Cruiser and made our way to the first village Sanananda. David Howell has a long association with the people of Sanananda including building war memorials, the guest house and providing solar lighting.

As we drove to Sanananda village we crossed paths with the village Chief Newman who was in the back of a Landcruiser going in and out of a coma.



Newman was on his way to the Popondetta General Hospital. Sadly, later that evening he would pass away. Believed to be from untreated diabetes.

Newman was a man who cared very much for his community and build helped to sustainable village creating income to many of the people of Sanananda. He is a sad loss for not only his people but for the country of PNG. He was 64 years of age.

The purpose of our visit to Sanananda was to speak with the local people and to collect two young men who would attend the first aid training in Kokoda. After great hospitality at Sanananda we made our way to Kokoda some 100km south. On route we stopped back at Popondetta town to take on supplies this is where we also learnt of the death of Newman.



Arriving at Kokoda we got straight into the registration of students, with over 27 people attending. The next two days we rolled out our first aid training package. The package enabled participants to gain such skills as the treatment of bites, cuts, burns, fractures and an abridged CPR component. The students were divided into three groups and three instructors ran 3 different bull rings each running for approximately 40 mins.

The students were very receptive and where eager to learn. Many of them had not had the opportunity to go to high school and their literacy skills where very low. Nonetheless they all were attentive and demonstrate at the end of the two-day course a high degree of competency. Each were awarded a certificate of participation and more importantly a SAFFA first aid kit which they could use back in the village. In 2020 when we return, it is hoped that we will training a similar group of people along with replenishing the first aid supplies into the kits of the graduating students.

Before we left Kokoda, we paid a visit to Sister Margaret at the Kokoda Hospital. We present Sister Margarete with a blood monitor machine kindly donated by Mr John Redmond and medical supplies kindly donated by Emergency Australia.

We are very much looking forward to rolling out a similar program in 2020 and empowering the descendants of the Fuzzy Wuzzy Angels the knowledge to be able to provide first aid in their villages.

The net operating position of the Charity for the financial year ended 30 June 2019 was a profit of \$2231.99, however, when we factor in our stock levels and the value of our assets, our position is sound at over \$65,000.

As at 30 June 2019, SAFAA has net investments of \$25,000 accruing interest @ 10% p.a. maturing on 05 Nov 2020. It has been re-invested.
