### **Our Values**

We believe people should always have access to free or low cost first aid assistance.

We recognise the importance of providing free first aid and first aid education to vulnerable people, and people with limited financial means.

We assert the provision of free first aid services and assistance are provided in a culturally sensitive manner and is offered by us at the same time as relieving poverty and improving their health and wellbeing.

We are committed to supporting and providing practical assistance through the provision of first aid services and assistance to people of limited means.

### **Aims and Purposes**

St. Andrew's First Aid Australia Inc. shall aim:

- a) to providing first aid assistance and support aimed at relieving poverty, and other risk factors in their lives;
- b) to find suitable and appropriate trained first aid volunteers to assist in our services;
- c) to provide in times of emergency or natural disaster physical assistance to persons through search or rescue and the provision of first aid services to all affected;
- d) to provide welfare and poverty relief through our first aid services and assistance; and
- e) to provide culturally relevant programs and services.

### About Us

1882 was the first year of activity for the St. Andrew's Ambulance Association and 173 cases of accident and sudden illness were removed from the streets of Glasgow and taken to hospital by litter. That year

the association provided itself with one ambulance.

In 1899, the Royal Charter was granted, being registered and signed on 02 May the sixtysecond year of Queen Victoria's reign.

At a council meeting in that same year, it was agreed that they carry on the work of the Red Cross Society in Scotland. Following upon this resolution, the Central

British Red Cross Committee recognised St. Andrew's Ambulance Association as a branch of Red Cross work in Scotland.

In 1900, the Association sent a Base Hospital to South Africa free of charge to the War Office. In 1908, the Council reported on the arrangements by which, on mobilisation, the Association would undertake to assume charge of the Military Hospitals in Scotland. During the Great War, the Association was requested by the War Office to furnish St. Andrew's Ambulance Association units for active service; where they served in casualty clearing stations in France and on hospital ships for the duration.

St. Andrew's Ambulance Association Australia was established as a company under Scottish Charter on 05 April 1976 by the Director General St. Andrew's Ambulance Association, Dr. Daniel Strachan, OBE.



Under the patronage of legendary WW2 POW Surgeon, Colonel Sir Ernest Edward 'Weary' Dunlop, AC, CMG, OBE, the first Australian Director was Artillery Officer Major General Sir Denzil MacArthur-

Onzlow, CBE, DSO, ED who commanded the 4<sup>th</sup> Armoured Brigade during WW2 and with Vietnam War Doctor, Group Captain William Land, AM, RFD, AE appointed Surgeon-in-Chief.

The first Companies were formed at RAAMC Military Hospital Healesville, Victoria, and St. Kilda Private Hospital, Victoria.

On 02 September 1980, our main base of operations had moved to the Ballarat East Company established at Begonia Hospital, Victoria.

Over the years the organisation grew steadily, and members served in many countries including: Armenia, Bangladesh, Bosnia, Chechnya, El Salvador, Iraq, Lebanon, Rwanda, Papua New Guinea and Timor-Leste, assisting a wide variety of Non-Government Organisations.

On 28 September 2006, the Association incorporated under the name St. Andrew's First Aid Australia Inc' (SAFAA) and reformed the Board of Management under the Chairmanship of Tom Hazell, AO. Steven McRae became the Chief Executive Officer and David Alexander-Fleming, JP moved to the position of Vice Chair and Corps Advisor. The Association re-engaged with St. Andrew's First Aid in Scotland and

refocused its primary aim to providing first aid with the same trading name as in Scotland.

In 2007, we recommenced public duties, providing first aid services at the Ringwood Highland Games, RSL Marches, The Aboriginal Literacy Foundation Camps, to name a few of our

long-standing events, and we began in partnership with Australian Premier Learning (our RTO) to once again offer courses in First Aid. On 24 May 2008 Dr Anthony Cree, OAM, PhD succeeded Tom Hazell as Chairman and in 2009 Malcolm and Jov Murray, the Earl and Countess Dunmore of became Australian Patrons. In January 2009, the Commandant-in-Chief and honorary surgeon to the Queen, Colonel Douglas

Bremner, TD, conducted an inspection of St. Andrew's First Aid Australia during a private visit. On 01 December 2011, Charity Status was granted and St. Andrew's First Aid Australia Incorporated became a Public Benevolent Institution.

On 23 November 2012 David Alexander-Fleming became President and CEO. We

commenced a very successful program with the Australian Army Cadets in Victoria providing them with first aid equipment and training.

In 2016; our fortieth year in operation in Australia,

we recommenced establishing First Aid



Companies in Victoria. We began exploring different revenue streams and ways to ensure our sustainability. We established the 'Society of St. Andrew' to embrace individuals who wish to support us without joining the Association. Our first Search & Rescue Support Company was also established to support the State Emergency Services (SES) when deployed

> in the field. In 2017 we formed St. Andrew's First Aid Pipes and Drums and commenced negotiations with the Victorian State Government about establishing a role for us in the Emergency Control Organisation (ECO).

> In 2018, The 15<sup>th</sup> Earl of Loudoun, Simon Abney-Hastings, became the Chairman of the Board of Governors, and six long serving members were

presented with their Voluntary Medical Service Medal by the UK Consul General for Victoria; Chris Holtby, OBE. We also fundraised and sent three trainers to PNG to increase the level of first aid knowledge along the Kokoda Track.

On 21 May 2018, Her Royal Highness, Princess Anne The Princess Royal,

became the Royal Patron of SAFAA.

On 17 December 2021 Captain Ian Young, AM, MD, FRACS, RAN was promoted to Chief Commissioner and assumed the position of President of the Association taking over from David Fleming who was made

a Life Member of the Association.

### **President's Report**


Registration became our only focus for 2022 and this was a much bigger task than expected. The *Non-Emergency* 

Patient Transport and First Aid Services Act 2023 was updated to include the Non-Emergency Patient Transport and First Aid Services (First Aid Services) Regulations 2021, which came into effect on 30 November 2021. The Regulations require licensing and registration for all providers of first aid services. This includes scope of clinical practice, staff competency, quality assurance, clinical governance, record keeping, patient rights, infection control, and liability insurance.

Our Chief Operations Officer, DCCOM Michael Krejany, led the way to reorganise and prepare St Andrew's First Aid Australia for licensing. By the end of 2022 most aspects of the provisions have been addressed and it is anticipated that we will be ready for licensing within the first quarter of 2023.

As President I am committed to the provision of high quality first aid services that meet or exceed all requirements of the Regulations. I sincerely thank the executive committee, and especially DCCOM Krejany, for their enthusiasm and due diligence. I also thank the membership for their patience as we complete our licensing process.

# **Chief Operations Officer's Report**



Much of 2022 as far as operations were concerned was taken up with licensing and getting key elements of operations up to speed.

This has been a sequential series of administrative tasks designed to bring us as an organisation to the standard that NEPT - Non Emergency Patient Transport Victoria and DHS - Department of Health Services has required from the new standards of every First aid service in Victoria Since November 2021.

This is still underway and I am happy to say progressing.

There were a number of traditional key events that we as an Organisation were not able to service due to the restrictions placed on us because of the need for licensing. However we were able to participate in a representation capacity which on the onset was viewed as necessary in order for us to maintain our contact and profile with our service community. Which was seen as equally important!

In terms of Organisational readiness to deploy members in the field - covid 19 had presented some residual issues. Like many Organisations reliant on face to face training - a training hole had created a lag in competency maintenance of our members putting many in a position where their first aid skills needed to be reviewed and updated. We are currently addressing these deficits and organising training days to up skilling our members who require it to deploy. With the completion of licensing we will be out on the beat and safeguarding the people of our precincts.

The new year brings new opportunities from an operational perspective, and therefore we will endeavour to meet, tackle, and succeed at every challenge this year for the benefit of St. Andrews and the people we service.
